

RESOLUTION NO. 2602

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CORCORAN ACCEPTING TO SERVE AS THE SUCCESSOR AGENCY TO THE CORCORAN REDEVELOPMENT AGENCY AND ASSIGNING THE HOUSING FUNCTIONS TO THE CORCORAN HOUSING AUTHORITY AND MAKING CERTAIN FINDINGS IN CONNECTION THEREWITH.

At a regularly scheduled meeting of the City Council of the City of Corcoran, held January 30, 2012, at the hour of 12:00 p.m., the following resolution was adopted:

WHEREAS, the Corcoran Redevelopment Agency (“Agency”) is a community redevelopment agency organized and existing under the California Community Redevelopment Law, Health and Safety Code Sections 33000, et seq. (“CRL”) and has been authorized to transact business and exercise the powers of a redevelopment agency pursuant to action of the City Council (“City Council”) of the City of Corcoran (“City”); and

WHEREAS, Part 1.85 of the Community Redevelopment Law (“Part 1.85”) as adopted by ABx1 26 (“AB 26”) provides for the statewide dissolution of all redevelopment agencies, including the Agency, and provides that, thereafter, a successor agency will administer the enforceable obligations of the Agency and otherwise wind up the Agency’s affairs, all subject to the review and approval by an oversight committee; and

WHEREAS, the City accepts the selection to become the successor agency, pursuant to Part 1.85; and

WHEREAS, by making such election, the City is making that certain election to perform certain housing activities as described in Health and Safety Code Section 34176(a) and is assigning all of the housing functions of the Corcoran Housing Authority; and

WHEREAS, the City has duly considered all other related matters and has determined that the City’s election to serve as successor agency to the Agency is in the best interests of the City and Agency and the health, safety, and welfare of its residents, and in accord with the public purposes and provisions of applicable state and local laws and requirements.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CORCORAN:

Section 1. The foregoing recitals are incorporated into this Resolution by this reference, and constitute a material part of this Resolution.

Section 2. The City Council hereby elects to serve as the successor agency to the Agency; such election is made pursuant to Part 1.85, Chapter 3 of AB 26.

Section 3. In accordance with the provisions of Health and Safety Code Section 34176(b), the City Council elects not to retain the responsibility to perform housing functions previously performed by the Agency and hereby assigns them to the Corcoran Housing Authority.

Section 4. This Resolution shall be effective immediately upon adoption.

Section 5. The City Clerk shall certify to the adoption of this Resolution.

BE IT FURTHER RESOLVED, that in the event that the Corcoran Housing Authority is dissolved, all assets and functions of said Authority will be transferred to the City of Corcoran as the successor agency.


