The regular session of the Corcoran City Council was called to order by Mayor Wadsworth Robertson, in the City Council Chambers, 1015 Chittenden Avenue, Corcoran, CA at 6:00 P.M.

There being no written or oral testimony, the hearing was declared closed at 6:18 p.m. Richard Gress, Tule Trash Co. owner, answered Council questions. Following Council discussion, a **motion** was made by Lerma and seconded by Palmerin to adopt amended Resolution No. 2690 adding rates for six yard solid waste bins and for collection and disposal of cardboard; further motion stated the

effective date of fee implementation was set at August 1, 2013 following thirty day notification to businesses by Tule Trash and city staff directed to assist with notification effort. Motion carried by the following vote:

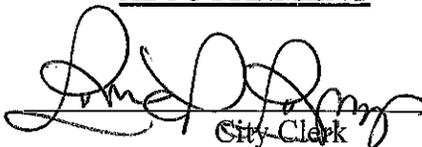

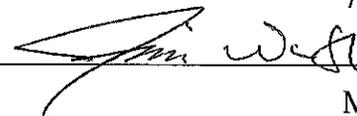
